- Not to take actions that would violate Internet Number Registry System's (INRS) uniqueness.
 - To take effective measures to promote Internet INRS.
 - To publish INRS entries publicly, so as to enable timely global Internet operations.
 - To cooperate in the provision of consistent, effective global INRS

NRO Strategic Focus

As a result of the NRO Strategic Review Process the NRO will focus in the below main three goals:

1. Provide a robust, coordinated secure **RPKI** service
2. Ensure the **cybersecurity** of the RIRs
3. Proactively **engage governments** as critical stakeholders in the success of the Internet Number Registry System

NRO Strategic Focus

- Each of the three strategic goals will be led by a Program Manager supported by RIR staff who reports directly to the NRO EC.
- All Programs will be part of the NRO budget, and the cost distributed among the RIRs according to the agreed annual distribution formula.

Finances 2022

- General operations: USD \$496,000
 - ASO, NRO and IANA Review Committee Secretariat support.
 - Communications (teleconferences)
 - ASO AC Chair travel to ICANN Meetings (travel restrictions permitting)
 - NRO Coordination Group meeting expenses
- IGF Contributions \$133,500
- Contribution to ICANN: USD \$823,000 (IANA Contract USD \$650,000 and voluntary contribution USD \$173,000)
- Stability Fund.
 - Joint RIR provision/pledge of over USD \$2.1M

- In February 2022, the NRO EC approved a contribution of USD \$250,000 to AFRINIC for legal representation expenses (applicable to 2021 NRO Expenses)
